# Where does PruFund invest across the Globe?

This interactive guide shows you just some of the ways the money you've invested in PruFund (PruFund Growth, PruFund Cautious, Risk Managed PruFunds) is invested in private markets across the world.

The PruFund range of funds leverage off the size and significant scale of M&G plc, an organisation that has £346.1bn Assets under Management and Administration (AuMA)\* and global presence with 39 locations worldwide across 27 markets. The global footprint of the company allows it to identify and capitalise on investment opportunities across different regions, providing customers with globally diversified portfolios.

The value of your investment can go down as well as up so you might get less back than you put in.

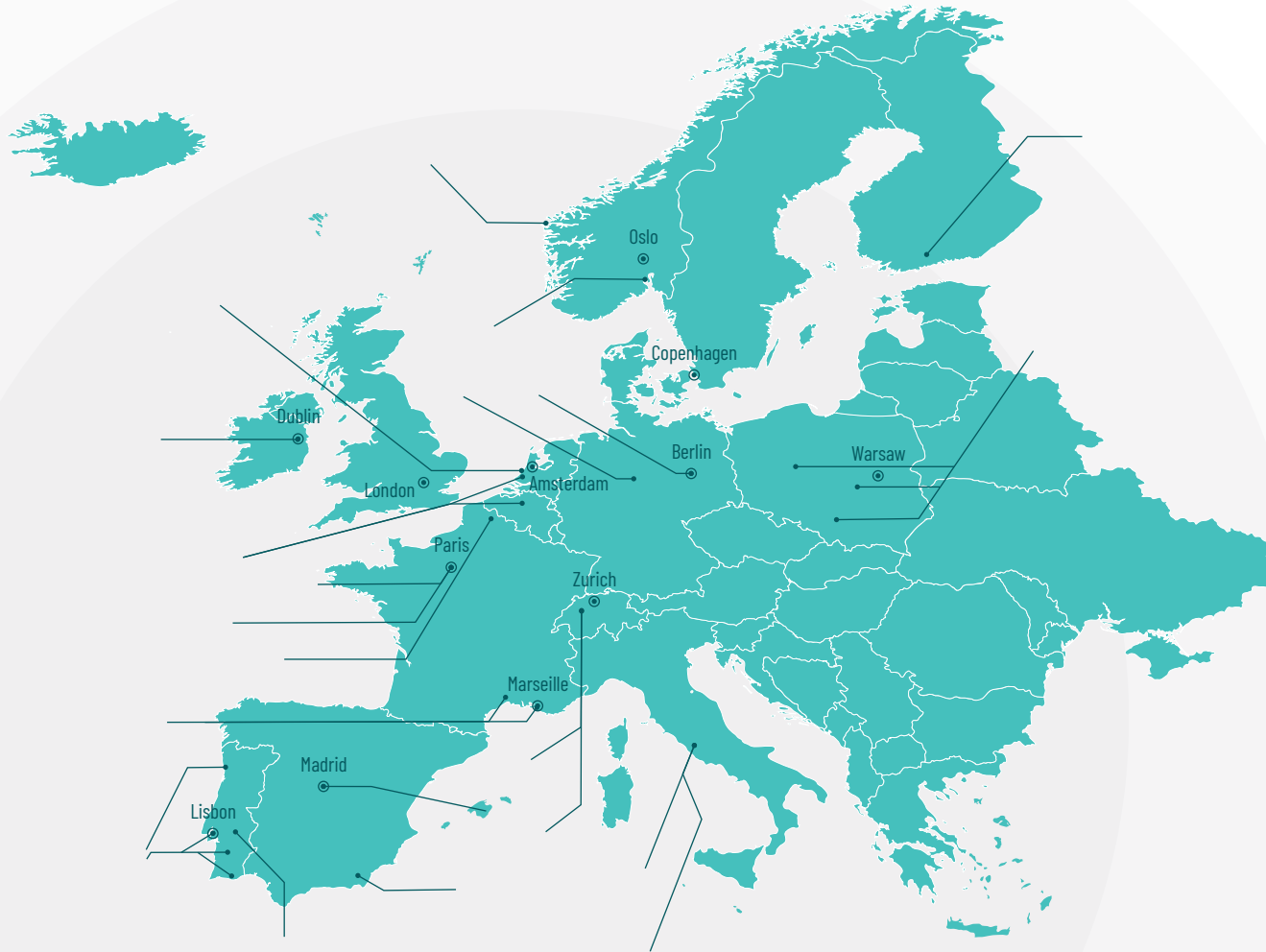


PruFund Growth/Cautious/Risk Managed – Public/Private investment split\*

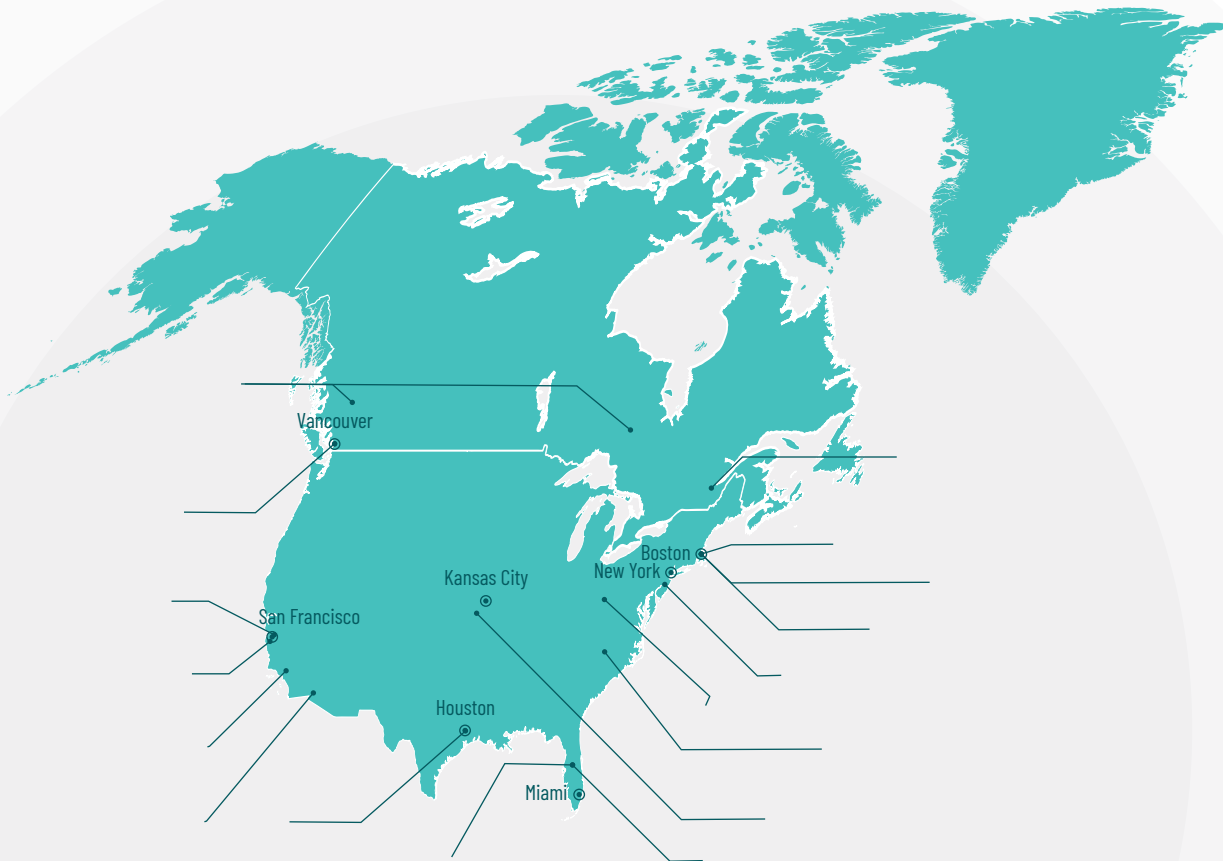

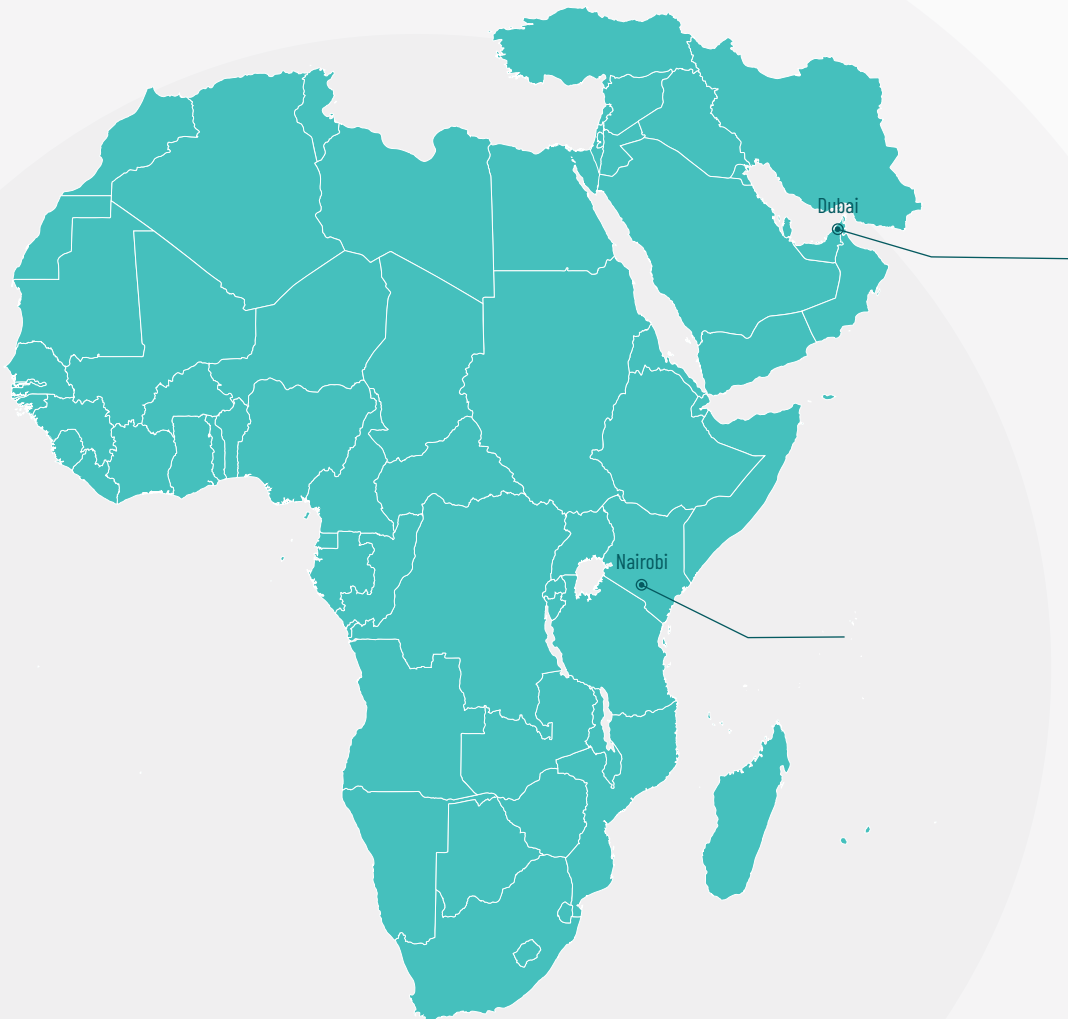

Currently the private market exposure to the Middle East and Africa is small and limited to only a handful of companies.

This is more reflective of the infancy of private markets and not a negative view on the continent as the With-Profits Fund and in turn PruFunds has been slowly building exposure to listed African equities and bonds over a number of years, such that Prudential Assurance Company is now one of the largest UK investors in African public markets.

In private markets, an example is Sun King, a really interesting business that has a demonstrable track record in delivering small scale solar power to off grid homes allowing them to generate enough electricity to power lights and domestic appliances.
