Insured Funds

The following information is intended to indicate the yearly charges for the Prudential Risk Managed Passive, Active and PruFund ranges and their availability through our current product range. Please note other charges may apply – please see the relevant product Key Features Document for more information: **pruadviser.co.uk**

The value of any investment can go down as well as up so your customer might get back less than they put in. The information in this document is correct as at January 2025.

Annual Management Charge (AMC)

This is the charge we take for looking after your client's investment. This is deducted from your client's annual return to give your client the net return on their investment.

Further Costs

These can include, for example, maintenance costs for property investments and costs associated with investing in infrastructure, such as utilities, transport and renewable energy. These costs can vary over time.

What is important to note is that they're already factored into the returns on your client's investment. This means they don't need to be deducted from your client's returns as they're already built into the fund.

The following are the Unit-Linked versions of our Risk Managed Passive and Active ranges. They operate like a OEIC but can only be accessed or held in a life, pension or international insurance product and can be distinguished from their OEIC fund equivalent by the omission of the prefix 'WS' in the fund's name. They are invested almost entirely in the OEIC fund equivalent and have the same 'Investment Objective' but differ in that they hold a slightly larger proportion of their holdings in cash and may be subject to different charging and taxation costs. Consequently their investment performance will be different to their equivalent OEIC fund.
