



# OCEAN HOUSING BORROWS £50M FROM M&G INVESTMENTS • Cornish housing association in private placement deal

### 4 November 2014

Ocean Housing Ltd ("Ocean"), the social and affordable housing business, has borrowed £50 million from M&G Investments ("M&G"), a leading international investment manager, in a long-term financing deal.

The 40-year private placement allows Ocean to fulfill its development ambitions to provide social and affordable housing in the long term. Ocean provides more than 4,200 homes throughout Cornwall.

Until 2007 housing associations generally relied on banks and The Housing Finance Corporation to meet their external funding requirements. In recent years non-bank lenders such as M&G are providing an increasing amount of longer-term finance as banks withdraw from this market.

**David Renwick, Group Chief Executive, Ocean Housing Group Ltd**, says: "We are delighted to have secured this funding from M&G. It will allow us to continue to invest in improving Cornwall's economy, creating jobs and training opportunities. Of equal importance will be the 500+ new affordable homes for rent and shared ownership and the contribution they will make in tackling the County's housing shortage."

**Mark Davie, Head of Social Housing, M&G Investments**, says: "Ocean plays a vital role in a region where there is both a severe shortage of housing and a growing population. Our pension fund clients continue to seek cash flows over the long-term which are secured against residential property. M&G has now invested over £5bn in UK social housing through property transactions, public bonds and private placements and we're keen to do more."
