M&G's impact

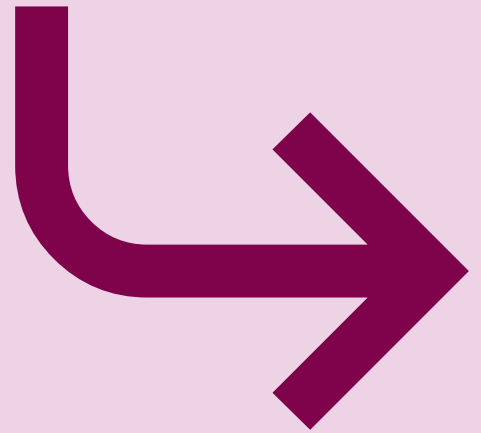
M&G has invested over £3bn in UK housing across 60+ housing associations over 20 years, plus £2.4bn in infrastructure projects.

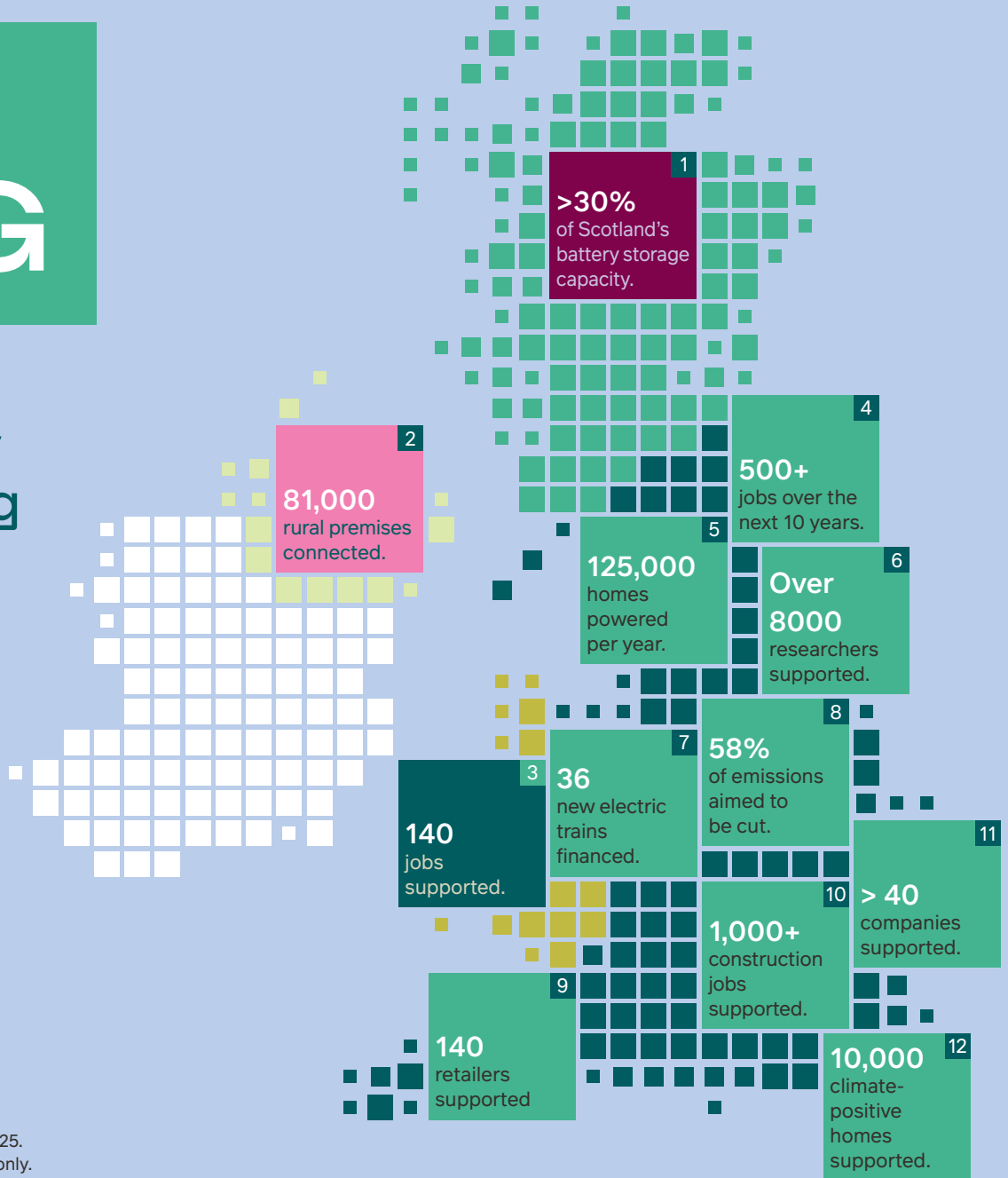
M&G has a dedicated impact investment strategy called Catalyst. Catalyst invests in companies with innovative solutions to some of the world's biggest environmental and social challenges.
